Primitive Tent Site Regulations

- Permit fees to be paid daily. \$15. Per weeknight, \$25 per Fri/Sat evening.
- Stay is limited to a maximum of three (3) nights per tent site. 5 people per/sites 1-9, 20 people per site 10
- Tent camping only in designated sites. (3 night max stay)
- Walk in only- No motor vehicles in camping areas at any time.
- No pop-up or RV camping.
- No camping in the parking lot(s).
- Tents and fires are limited to designated tent sites only.
- Minimal noise after 10 p.m. No radio or speakers after 10pm.
- All fires* must be doused with water and the bucket must be refilled before you leave.
- Area must be kept clean.
- All trash must be placed in trash barrels at Park. No littering.
- Tent site must be vacated by 10 a.m.
- All vehicles associated with the Tent site must display the Parking Permit issued.
- *If there is a Burn Ban in effect, absolutely NO Fires will be permitted.

Permit fees to be paid daily.
Site capacity for sites 1-9 is 5 people max.
Site capacity for site 10 is 20 people max.
Stay is limited to a maximum of three (3) nights per tent site.
Tent camping only in designated sites.
Walk in only- No motor vehicles in camping areas at any time.
No pop-up or RV camping.
No camping in the parking lot(s).
Tents and fires are limited to designated tent sites only.
Minimal noise after 10 p.m. No radio or speakers after 10pm.
All fires* must be doused with water** and the bucket must be refilled before you leave.
Area must be kept clean.
All trash must be placed in trash barrels at Park. No littering.
Tent site must be vacated by 10 a.m.
All vehicles associated with the Tent Sites must display the Parking Permit issued.
Please note: No potable water at sites.

*If there is a Burn Ban in effect, absolutely NO Fires will be permitted.
**Water is to be obtained from the river. There is no potable water offered at the Tent Sites.
